Working Together

Adult Day Association

CANPFA was pleased to continue to provide management support for the *Connecticut Association of Adult Day Centers*, an arrangement that has been working successfully for the past decade.

Smart Moves Initiative

The *Smart Moves* initiative was collaboratively developed by CANPFA, the Connecticut Hospital Association (CHA), the Connecticut Nurses Association, Connecticut Association of Home Care and Hospice, and Connecticut Association of Health Care Facilities to advance the concepts of safe patient handling for direct care staff. The second annual *Smart Moves* conference was held in February 2008 at CHA and featured CANPFA member *Kelly Smith Papa* of the Alzheimer's Resource Center as a breakout session instructor.

2008 Legislative Review

Advocating on behalf of our members is a priority for CANPFA. Whether it was at the state Capitol or within the state agencies, CANPFA's staff and consultants continued our strong advocacy efforts in 2008. Through the strength and integrity of our membership, we had a strong voice on the issues that meant the most in long term care.

CANPFA's team of well-respected consultants: legal counsel **Maureen Weaver** of *Wiggin and Dana*; contract lobbyist **Keith Stover and his staff** of *Robinson & Cole* and financial consultant **Ron Durie** from *Blum Shapiro* provided their considerable expertise and positioned us well as we worked to achieve our goals in 2008 and 2009 and beyond.

Legislative Session Highlights

The 2008 Connecticut Legislative Session was strongly influenced by the Hartford Courant's front page exposé of one particular skilled nursing home chain in the state. This nursing home story produced several legislative initiatives to increase nursing home oversight and staffing minimums. While the story overshadowed most of the session, the economic downturn became more and more evident as the session progressed and the shrinking state surplus finally took precedent. As a result, the Governor and the Legislature agreed not to open up the two year state budget that had been voted into place in the previous session. This was extremely disappointing because the skilled nursing facility and home and community based provider rates were not scheduled for an increase at the midterm of that budget and without the Legislature opening up the budget, we were unable to amend it to provide for increases in FY 2008-2009.

Despite this disappointment, there was a groundswell of support to reinstate the housing tax abatement funds for 2008, but for just one year. This is an issue that affects several CANPFA housing members and there needs to be a permanent restoration of those funds.

The session ended without a nursing home staffing or financial oversight bill being passed. An unfunded staffing bill was called late on Wednesday night in the House, but time was running out and when the Republican members began to filibuster on the bill, the House leadership pulled the bill from the floor before a vote – thus defeating it for this session. In the meantime, drafts of a comprehensive financial over-

sight bill were being negotiated between the Administration and the Legislature. However, no agreement was reached by the midnight deadline and therefore the bill died. We anticipate both issues will be back in the 2009 session.

Special Sessions Deal with Deficit

The Legislature had to deal with a growing state deficit by calling additional special sessions throughout the year. The state will face even tougher times ahead with deficit projections for the next two fiscal years predicted to be \$2.6 billion and \$3.3 billion. CANPFA is prepared for the 2009 session because never before has strong statewide advocacy been so important.

Grassroots in Action for 2009!

In these difficult budgetary times and in the even more difficult times ahead, grassroots communication from our members will be extremely important throughout 2009. That is why CANPFA has put into place additional resources and consultation services to further develop our grassroots advocacy to make it even more strategically effective.

Partnering for Quality

CANPFA continues to be called upon by the Depart- . Long Term Care Advisory Council ment of Public Health (DPH) as a collaborative partner! In 2008 CANPFA once again partnered with . Qualidigm DPH and others to plan and endorse a COOP planning program. CANPFA partnered with DPH, the Connecticut Association of Home Care and Hospice. Connecticut Association of Health Care Facilities and the ESRD Network to jointly plan a major program on Continuity of Operations Planning for Pandemic Influenza. The conference focused on implementing specific strategies and procedures, across settings, in the event of a public health crisis. Pressure Ulcer Collaborative Project

CANPFA continued its collaborative partnership with Qualidigm as leaders of the collaborative pressure ulcer project on behalf of the Department of Public Health's Quality of Health Care Continuum of Care Subcommittee. The Connecticut Hospital Association, Connecticut Association of Home Care and Hospice and Connecticut Association of Health Care Facilities are also partnering with CANPFA on this Pressure Ulcer Collaborative Pilot Project aimed at coordinating the prevention, care and treatment of pressure ulcers throughout the continuum. The project is scheduled to kick off in early 2009.
